

HIGHLIGHTS: Joint TIC Council and EUIPO Webinar - 'Nonconform imported PPEs, with medical devices and fake certificates'

On 28th May, TIC Council hosted a joint webinar together with European Union Intellectual Property Office (EUIPO) on 'Non-conform imported PPEs, with medical devices and fake certificates.

The webinar was led by the TIC Council's Anti-Counterfeiting Committee to work towards halting the worldwide proliferation of products bearing counterfeit certification marks that have been endangering public health and safety measures in fighting the spread of COVID-19. In addition, these rapidly emerging cases of conformity assessment certification fraud is of extreme threat to the validity and integrity of the TIC Industry.

High-level panellists representing European institutional and law enforcement agencies consisting of EUIPO, the European Anti-Fraud Office (OLAF) and Europol provided participants insights into the current status of the problem, coordinated actions and operations undertaken to fight the spread of rogue operators. Furthermore, representative members from TIC Council provided practical case studies of circulating counterfeit certificates to give tips on how to depict the methods and formats used by criminals to break into the PPE industry market. The main role of this webinar was to alert the relevant stakeholders and share good practices and useful information that could help in the identification of fake certificates and non-conform equipment.
