The role is responsible for supporting the Executive Director Americas in identifying, researching, and preparing outreach campaigns to reach U.S. policymakers and regulators, industry, consumer organizations and NGOs to advance TIC Council goals to enhance awareness about the value of the TIC sector. ("TIC" means Testing, Inspection, and Certification)

The position will include cross functional coordination with staff in Brussels (HQ), India, and Asia, administration of committee work, research support in the development of policy and stakeholder mapping and outreach, and/or the development of communications strategies.

Interns will be provided with:

- Education on standardization and conformity assessment and its role within quality infrastructure
- Education on policy making
- Training on developing policy maps and outreach campaigns
- Experience developing policy strategy in areas such as digitalization, trade, sustainability and consumer safety
- Experience working with industry stakeholders to develop consensus positions
- Experience meeting with regulators and legislators

The position is remote and part-time with flexible work hours to accommodate school schedules.

Applicants will gain valuable insight into an industry with over one million TIC employees (often in highwage STEM jobs) scattered in more than 160 countries around the globe confirming the safety and reliability of products, systems, and services, and protecting the security of consumer and national interests. Areas of focus include Digitalization (Cybersecurity, AI, IoT), Trade, ESG (Environmental, Sustainability, and Governance), and Consumer Product Safety and Compliance.

This internship would be a good fit for any student seeking a career as a policy analyst, advocate, lobbyist, specialist in international relations, or wishing to pursue a career in the nonprofit sector.
